
Development of Specialty Work Group

 - Laura Topor - Granada Health, Inc.





SRx WG Scope & Goals




- Identify **pain points** and **transactions** that delay the prescribing, dispensing, care management, reporting, and payment of specialty medications and determine if an existing electronic transaction and/or standard can be used or enhanced to improve the process.
- Drive **increased participation** in the following membership categories:
 - Pharmaceutical Manufacturers
 - Prescribers
 - Software Vendors
 - Specialty and Compounding Pharmacies
 - Ancillary service providers, such as hubs and infusion centers
 - Care Providers, such as health systems, long term care, and home care
 - Accreditation bodies
- Develop **new standardized transactions** and messages for prescribers, pharmacists, payers, manufacturers and other interested parties in exchanging information related to specialty prescriptions (e.g., enrollment, reporting).
- Review Data Element Request Forms (DERFs) and adjudicate ballots pertaining to standards for which this work group is responsible.

Task Groups Assigned to WG18- Specialty Pharmacy

- **Benefit Coverage Identification Task Group**
 - Created to address the areas of opportunity related to determining if coverage is through the medical or pharmacy benefit.
- **Specialty Pharmacy Data Exchange Task Group**
 - New use cases are being explored that involve other stakeholders.
- **Specialty Requirements for ePrescribing Task Group**
 - Works on ePrescribing and related transactions
- **Stakeholder Outreach and Education Task Group**
 - Created to provide outreach to Specialty Pharmacy stakeholders and develop and execute education opportunities.





 - Will my insurance pay for this medication?




Specialty Workflow Challenges: There's a standard for that

STANDARD	DESCRIPTION	WHO SHOULD IMPLEMENT?
Formulary and Benefit Check	Displays patients prescription benefit information to the prescriber including: On/Off formulary, tier level, coverage restrictions (i.e., Prior Authorization required, Step-therapy required, Age limits)	PBMs and EHR vendors
REMS	Automates the REMS process between prescriber and pharmacies and REMS Administrators	REMS Administrators, Pharmacies and EHR vendors
Electronic Prior Authorization (ePA)	Allows a prescriber to respond to payer question sets and requests for additional information for prior authorization requirements electronically	Pharmacies – new pharmacy initiated use case
Specialty Pharmacy Reporting and Data Exchange	Dispensed Medication reporting standard between pharmacy and manufacturer	Pharmacies and Manufacturers

Specialty Workflow Challenges: Work in Process

STANDARD	DESCRIPTION	WHO SHOULD PARTICIPATE
Real-Time Pharmacy Benefit Check (RTPBC)	Provides real-time information on patient pharmacy benefit including alternatives and more accurate patient cost information	PBMs, EHR Vendors, Pharmacy System Vendors
Specialty Requirements for ePrescribing	Automation of specialty enrollment process	Pharmacies, EHR Vendors, Manufacturers, HUB Vendors, HIT Software Vendors
Benefit Identification	Focus on how to begin to unravel question of where to bring specialty drug prescriptions or orders	Pharmacies, EHR Vendors, Manufacturers, HUB Vendors, HIT Software vendors, PBMs, Medical Payers
Specialty Pharmacy Reporting and Data Exchange	Reviewing multiple use cases where data needs to be exchanged between stakeholders in the specialty medication prescribing and dispensing process	Pharmacies, EHR Vendors, Manufacturers, HUB Vendors, HIT Software vendors, PBMs, Medical Payers
