


# The ePA State Navigator Advantage



State mandates impacting prior authorization (PA) have escalated since the passage of H.R.6 / SUPPORT for Patients and Communities Act in the fall of 2018. H.R. 6 mandates all covered Part D drugs requiring PA must be electronically submitted to Part D sponsors and processors electronically — and responded to electronically — by January 1, 2021.

# Why are states and Federal government focused on streamlining the Prior Authorization process?

- Approximately 11% of prescription claims are rejected at the pharmacy
- On average, 66% of rejected prescriptions require PA and 37% of those will be abandoned due to the complex paper-based process
- Prescription abandonment increases the risk of future health problems or hospitalization for the patient
- Patients get their medications an average of 13.2 days sooner when the prescriber submits an electronic prior authorization (ePA) vs. pharmacy initiated ePA<sup>1</sup>
- Cancer patient delays in receiving lifesaving treatment due to prior authorization has been found to be associated with a 1.2% to 3.2% increase in patient mortality<sup>2</sup>

States are focused on streamlining the PA process in response to H.R.6, taking varied approaches such as the use of uniform ePA forms, mandates and in some cases requiring NCPDP and other standards. States are also adding stipulations for both prescription drugs and medical services to require timely responses to PA requests.
